**eHealth2020 – International Conference & The 25th Finnish National Conference on Telemedicine and eHealth, "From Dream to Reality" 20.-22.4.2020, risteily kahden pääkaupungin Helsingin ja Tukholman välillä.**

Vuoden 2020 kansainvälisessä konferenssissa käsitellään teemoja ja tuodaan uusinta tietoa kansainvälisestä, pohjoismaisesta sekä kansallisesta digitaalisesta terveydenhuollon kehityksestä ja ratkaisuista.
