Notes for Contributors

Policy: The Association's Yearbook is published on an annual basis. Every article is refereed by at least two anonymous referees.

Language of Publication: Contributions should be written in an international conference language (English, German, or French). If the article is not written in the native language of the author, the language should be revised by a qualified native speaker before submission.

Submission of Manuscripts: Manuscripts (in 3 copies) should be submitted to the Editors.
