FROM THE EDITORS

Helsinki Law Review was founded 10 years ago, in January 2007. In this issue, *Ville Kari*, the first Editor-in-Chief and one of the founders of the Review, sheds light on circumstances which prevailed when this academic journal was born. From our current standpoint, it's interesting to learn what the founders felt. According to Kari the first Board of Editors were worried about continuity.

Helsinki Law Review is administered by students. Typical career as an editor takes 1–2 years during studies. Regardless of high turnover rate there has formed a solid tradition of practices and principles which guide the editing process in Helsinki Law Review.

After ten years, it can be stated that the Review has received a warm reception from readers, writers and law students. The journal has gained ground as a publication channel for undergraduates and young lawyers.

There is still a lot of work to be done. Ville Kari points out the possibility to seek a formal recognition to Helsinki Law Review from Finnish scientific societies. That will be a daring journey with setbacks and backlashes – but not without cultivation and refinement.
